

PRIVACY POLICY

The Coureurs des Vignes website is owned and operated by Ungava Spirits Co. Ltd. (collectively hereafter "Site Owner").

1. **PERSONALLY IDENTIFYING INFORMATION:** Industry standard online monitoring functions used at our site enable us to anonymously track and aggregate statistical information such as what areas of our site are most visited, what browser software visitors use, and which websites users arrive from. Cookies are small files containing numerals or alpha characters placed on your hard drive which convey these types of nonpersonally identifying statistical information about a visitor. Visits to our website are anonymous and do not convey personally identifying information unless the user at some time voluntarily provided the information to us, for example in an email, by entering an online contest, or by completing one of our other online forms.

You may disable the use of cookies by using the disabling option in your browser software, or you may delete cookies using options provided in your browser software. Disabling cookies and the functions they perform may interfere with your ability to smoothly experience all features of our website and other sites that may rely on cookies to track visitors.

If you would like your visit to our website to remain anonymous, please do not supply any personally identifying information when visiting our site, and please use the optional communication methods indicated below.

2. **HOW WE MAY USE YOUR INFORMATION:** Personal information that you provide through email or by completing one of our online forms may be used for marketing research, to improve customer service, or to communicate with you about contests, product updates, and other promotional activity. We or our third-party list managers may send you email about our products, promotions, or services as well as those of other partner companies to whom we provide customer information.
